**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely, **B.E.A. College of Education, MCC 'B' Block, Davanagere – 577004, Karnataka** vide SRC vide order no. F. F.KAR/B.Ed/15/SRO/NCTE/2000-2001/914 dt. 10.07.2000 for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. **AND WHEREAS**, the SRC in its 244<sup>th</sup> meeting held on 9<sup>th</sup> – 11<sup>th</sup> May, 2013 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.No. APSO3341/B.Ed/KA/2013-14/52308 dated 17.06.2013 was issued to the institution.

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations.

4. **AND WHEREAS**, the permission is hereby accorded to restored/continued & shift the institution to its new permanent premises at **S. Nijalingappa Layout, 2<sup>nd</sup> Main, 11<sup>th</sup> Cross, Davanagere -577004, Karnataka** vide order no. F.SRO/NCTE/APS03341/B.Ed/KA/2015-16/63522 on 27.04.2015 was issued to institution.

5. **AND WHEREAS**, a revised provisional recognition order was issued to the institution on 16.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units of 50 students** each from the academic session 2015-16.

6. **AND WHEREAS**, the SRC in its 321<sup>st</sup> meeting held on 28<sup>th</sup> & 30<sup>th</sup> September, 2016 considered the matter and decided to issue letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 15.10.2016. The institution has submitted reply on 18.09.2020.

7. **AND WHEREAS**, the SRC in its 389<sup>th</sup> meeting held on 12<sup>th</sup> & 14<sup>th</sup> October, 2020 considered and decided to issue last reminder letter. Accordingly, as per the decision of SRC last reminder letter was issued to the institution on 21.10.2020. The institution has submitted reply on 07.11.2020.

8. **AND WHEREAS**, the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> - 12<sup>th</sup> August, 2021 considered the last reminder letter reply matter and decided as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The institution was issued a Last Reminder Letter. The institution has submitted its reply on 07.11.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.*

1. The institute submitted a proforma of faculty signed by the Registrar, Davangere University but date of approval has not been mentioned.
2. Faculty namely Smt. R. L. Shylaja is not qualified as possessing less than 55% marks in P.G.
3. Principal has not been appointed.
4. The institution has submitted photocopy of Building plan which is neither legible nor approved by competent authority.
5. Faculty strength is not enough for one unit of B.Ed. course.
6. Form 'A' has not been submitted for FDRs. of EF & RF.
7. The Website of the institute is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
8. NEC has not been submitted.

Hence, the Committee decided to **withdraw the recognition** granted to **B.E.A College of Education, S. Nijalingappa Layout, 2<sup>nd</sup> Main, 11<sup>th</sup> Cross, Davanagere, Karnataka-577004** for conducting **B.Ed. programme** with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

9. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **B.E.A College of Education, S. Nijalingappa Layout, 2<sup>nd</sup> Main, 11<sup>th</sup> Cross, Davanagere, Karnataka-577004** for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students (2 basic units)** w.e.f. the next academic session i.e., 2021-2022 onwards.

10. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

***"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."***

11. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
